It has the power to make rich person, a poor person in seconds! That is why it gave birth to many offences also, such as: Murder, Suicide, Kidnapping,

Harassment, etc. Betting is also 'Gambling'. The fun fact is that Gambling is no more a newer concept. However, it started in Dwaparyug. In the 21st century, many people have started making money in cash by placing bets upon the gambling activities in India. Casinos have been set up for gambling in some states. For example, Goa. Critics of betting claim that it leads to crime, corruption, and laundering.

## Online gambling in India

There are two types of online gambling available in India. One is casino-type gambling in which gambling takes place online in casinos and the second one is gambling on various sports and events through various applications and websites. Sikkim and Goa, are only places in India which allows online gambling while Sikkim is the only state which allows casinotype gambling. On the other hand, various applications like Dream 11, My 11 Circle, Junglee Rummy, etc allows the user to make money online. However, it is totally legal, Government deducted tax on the money that is earned by the users through gambling. There is a very interesting story behind the legalisation of online gambling. Previously, it is illegal to do gambling online. After, that Dream 11 (an application which allows betting in the game of cricket) has launched. Some people sue Dream 11 say, that it is based on the concept of betting which is illegal as no skill is needed and it has to be banned. But as a result, Dream 11 lawyers argue in the court and mention that in Dream 11, people have to make their teams on the basis of their knowledge in Cricket and if the player chosen by them performs then only they earn money. They further argue that the process of choosing the players need some skill. As, people who doesn't has the knowledge of Cricket doesn't able to make teams and did not have the capability to win. Therefore, Court granted allowance to Dream 11 and many other fantasy apps and sites which have the concept similar to it. In 2010, Sikkim gives three online gambling licences. By 2022, other states follow Sikkim,

thereby opening up a major online gambling market known as Matka gambling.

## Legalisation of Betting in India

As we know that there is not a particular source of law regarding betting in India. If we look towards another countries, then gambling laws are very confusing and critical as every country has separate laws regarding gambling. But, if we talk about India only, then the whole country has only two laws: Public Gambling Act, 1867 and Technology Act, 2000. Under, these laws every state in India has the power to set up their regarding gambling in India. own laws According to Public Gambling Act, 1867 gambling is not legal in India but unlike United States India doesn't have a specified set of laws to prohibit gambling. Online betting companies catch the loopholes in the laws of India and do their betting business without any fear.

As mentioned above, every state of India has the power to establish their own laws, the same would followed by the state of Sikkim. On 4th March 2009, Government of Sikkim issues the provisions regarding betting. Sikkim Online Gaming (Regulation) Rules, 2009 which has all the clauses regarding online betting which takes place in the state of Sikkim. If like Sikkim, each and every state set laws regarding betting then it is possible for Indian Government to throw this practice out of the country but unfortunately practically it is not possible.

### Some Famous Sports Betting Scandals in India

Raj Kundra Case:

Raj Kundra is the businessman and the husband of the famous Bollywood actress Shilpa Shetty. He was the owner of the IPL franchise Rajasthan Royals. On 5th June, Delhi Police questioned him regarding match fixing in 6<sup>th</sup> edition of IPL. On 6<sup>th</sup> June, he confessed that he has placed bets through a bookie who was his friend. On 7<sup>th</sup> June, the management of Rajasthan Royals announced that the Raj been suspended from Kundra has ownership of the franchise if the charges

framed against him has been proved in the court. On 10<sup>th</sup> June, he was proven guilty and therefore he has been banned from the IPL from the BCCI.

#### Gurunath Meiyappan Case:

Vindu Dara Singh is the popular Bollywood actor and the son of famous wrestler and the Bollywood actor Dara Singh. His call records with IPL franchise Chennai Super Kings' team principal N. Srinivasan's son-in-law Gurunath Meiyappan showed that they would involve in some betting scandal. To, investigate this matter, Mumbai Police issued summons against him. On 24th May, 2013 Meiyappan arrested on the charges of betting, conspiracy, and cheating by the Mumbai Crime Branch. On 24th May, 2013 in a press statement India Cements which owns the CSK's franchise said that Mr. Meiyappan was no longer to remain the team owner or CEO. He was only the honorary member of the management of the team. The main reason for this is his arrest. However, on 26th March, 2016 BCCI appoint a three-member commission for investigation in Meiyappan case and as a result, he would declared 'not quilty' by this commission on 31st May. Therefore, on 3<sup>rd</sup> June, 2016 he was released on 'bail' by the Mumbai Court.

#### Conclusion

India doesn't have a proper set of laws regarding betting unlike the different countries. In the name of betting it only has two laws which is not enough to decrease the activities related to gambling. If Indian Government wants to protect India from the ill effects of betting then they have to increase the transparency in the betting activities and set a proper set of laws regarding gambling. They have to set such a law which has a capability of governing these online betting sites. The law requires to be perfectly drafted by the Government without any loopholes.
